Registration Fee

First time enrollment fee: \$250 (non-refundable) Re-enrollment fee: \$200 (Non-refundable)

Wait-List Fee

If applicable, a wait-list fee of \$150 will apply towards the registration fee, when a space opens up.

Tuition Deposit

A one-month's tuition deposit is required and due at the time of enrollment. This will apply to the last month's tuition of the child's contract year. The one-month's tuition deposit will **NOT** be refunded if the child fails to complete the full school session.

FACTS

- Monthly tuition payments are made to FACTS Tuition Management via automatic bank payments on the fifth (5th) of each month.
- Late fee of \$35 will apply for tuition paid after the 5th of the month.

Inclement Weather Fee for School-Age: \$12/hour will apply if a School-Age Extended Day child stay on an inclement weather day beyond the number of scheduled hours allotted for that day.

Sibling Discount: 10% discount (applied to the lesser tuition amount)

Additional Hours

- Authorized non-contract hours (before closing): \$15/hour with 24-hour advanced notice.
- Unauthorized non-contract hours (before closing): \$20/hour for any unauthorized late pick-up.

Late Pick-Up Fees

After 6:00 P.M., the late pick-up fee is \$1/minute for the first 10 minutes, \$2/minute for the next 10 minutes, and \$3/minute thereafter, until the child is picked up.

<u>Program/Schedule Changes</u>: A 30-day's written notice is required to change the child's program/schedule.

1st change: free of charge 2nd c

2nd change: \$50

3rd change: \$75

Every change thereafter: \$90

<u>Withdrawal</u>: A 30-day's written notice must be submitted on or prior to the first day of the month, during which the child will cease to attend.
